
Tri-Faith Initiative FACT SHEET

What is the Tri-Faith Initiative?

The Tri-Faith Initiative is a complex of buildings being constructed at 132nd and Pacific St., Omaha, NE. It will consist of a synagogue, a church, a mosque and a community center, which will be used by all three faiths. It is the first such complex of this type in the world. (The original Christian component of the triad has backed out of the project and negotiations are underway with a replacement church of a different denomination.)

Why should I be concerned?

The Tri-Faith Initiative has connections to known Muslim Brotherhood front groups - CAIR, ISNA & MSA. Below is a model of how the groups are linked.



How does this affect me?

The stated goal of the Muslim Brotherhood is to destroy the Judeo-Christian values of America. Acting through their front groups, they hijack interfaith projects – like the Tri-Faith Initiative – using them to further disseminate Islamic propaganda and to radicalize populations.

The FBI unearthed a Muslim Brotherhood planning document describing these methods in detail.

'The Ikhwan [Muslim Brotherhood] must understand that their work in America is a kind of grand Jihad in eliminating and destroying the Western civilization from within and "sabotaging" its miserable house by their own hands and the hands of the believers so that it is eliminated and God's religion is made victorious over all other religions....'

The Muslim Brotherhood has been banned from Egypt and Saudi Arabia because of its fundamentalist doctrine and history of violence.

How does this affect Omaha’s Countryside Community Church?

The Episcopal Church has withdrawn from the Tri-Faith project. The Catholic Church has already declined an invitation to participate, leaving Countryside Community Church as the Tri-Faith Board’s best hope to move this project forward.

What is the Global Faith Institute asking?

We are asking the Congregation of Countryside Community Church to take up the cause of progressive Muslims in Omaha, NE by making their Church’s participation in the Tri-Faith Initiative contingent on the mosque cutting all ties with the Islamic Society of North America (ISNA), the Council on American/Islamic Relations (CAIR) and other similarly extremist Muslim organizations.

Why?

Past experience shows that mosques that partner with these groups soon bring in Imams (pastors) from places like Pakistan and Egypt who preach violent jihad and hate of westerners. This is not a good environment for Muslims who are trying to break away from the violence of Islam and the subjugation of Sharia law. A true interfaith dialogue is unobtainable with the involvement of known supporters of radical Islamic supremacy.

What can I do?

Petition

The Global Faith Institute has requested that the Tri-Faith Initiative do the following:

- **Renounce the Muslim Brotherhood and the use of terrorism. Repudiate terror groups like Hamas and Al Qaeda.**
- **Sever relations with the front organizations of the Muslim Brotherhood, specifically CAIR, ISNA, and MSA.**
- **Cease fund-raising activities and/or events associated with these organizations, and open your accounting books to independent audit to provide transparency. If funds have already been accepted from said Organizations, these monies are to be returned immediately.**
- **Publicly state your position on the Koran and Islamic hadiths calling for the subjugation of non-Muslims.**
- **Accept and promote the pre-eminence of the U.S. Constitution and American law over the dictates of foreign or Sharia law whenever their views conflict.**
